# Division Specifications

---

**Lead Line**—Riders are escorted by a lead. Judged on Rider’s turnout, and position. Riders may not cross enter. Year end prizes awarded on attendance.

**Pre-Short Stirrup**—Open only to Junior Members\*\* who will not be showing in any Canter class. Riders cannot cross enter into any over fences or canter class. Riders will trot over 2 poles on the ground (2 point position over poles.).

**Short Stirrup**—(Judged as an Equitation Division) Open to riders who have not reached their 13th birthday as of December 1st, 2009. Trotting and Trotting changes are permissible. Riders cannot jump over 18” in any other class. Four fences at 18”. NOTE: GRHSA Short Stirrup is **NOT** a VHSA Associate Division.

**Pleasure Pony\***—Open to all Junior Members\*\* on ponies. VHSA Associate Division.

**Novice Equitation**—Open to Junior\*\* and Amateur riders. No more than six(6) fences. Trotting changes are permissible. Riders cannot cross enter into any over fences class over 2’.

**Open Equitation**—Open to Junior\*\* and Amateur riders showing in classes with fence heights of 2’ or lower. No more than six(6) fences. Trotting changes is permissible.

**Student Hunter**—Open to Juniors\*\* or Amateurs on horses or ponies. Riders will jump a course of six(6) fences of 2’ or 2’-3’. No more than six(6) fences.

**Pony Hunter\***—Open to Juniors\*\* on Ponies. Fences: Small—2’, Medium—2’-3’, Large 2’-6’. VHSA Associate Division.

**GRHSA/VHSA Associate Pony Equitation**—Open to GRHSA and VHSA Associate Junior members\*\*. Judged on hands, seat, control. At least one quarter of riders must return on the flat. Fences: Small—2’, Medium—2’-3’, Large 2’-6’’

**Pleasure Horse\***—Open to all horses. Junior\*\* and Adult may be split if entries warrant. VHSA Associate Division.

**Long Stirrup**—(Judged as a Hunter Division) Open to riders who have reached their 13th birthday as of December 1st, 2009. Trotting and Trotting changes are permissible. Rider and horse/pony must not show over 18” in this show. Four crossrails at 18”. NOTE: GRHSA Short Stirrup is **NOT** a VHSA Associate Division.

**Baby Green Hunter**—Open to horses and ponies in their first or second year of showing. Horses cannot cross enter into any classes with a fence height over 2’. Adults may ride ponies. Fences—2’. Four(4) to six(6) fences.

**Low Hunter**—Open to all riders on horses or ponies. Fences: 2’, or 2’-6’’. Six to eight fences.

**Open Hunter\***—Open to all Riders on horses. Fences: 2’-6’’. Eight(8) fences. VHSA Associate Division.

**Children’s/Adult Hunter\***—Open to Juniors\*\* and Adult Amateurs on Horses only. Junior and Adult may be split if entries warrant. Fences 2’6’’. VHSA Associate Division.

**GRHSA/VHSA Associate Children’s/Adult Equitation\***—Open to GRHSA and VHSA Associate Junior members and Adult Amateurs. On horses. Judged on hands, seat, control. At least one quarter of riders must return on the flat. Fences: 2’-6’’. Junior and Adult may be split if entries warrant. VHSA Associate Division.

**GRHSA/VHSA Associate Green Pony/Horse\***—Open to Juniors \*\* on ponies in their first year of showing at or above designated heights and horses in their first or second year of showing over fences at or above 2’6’’. Fences: Small—2’, Medium—2’3’’, Large and Horses—2’6’’. Pony and Horse may be split if entries warrant.. VHSA Associate Division.

**\*\* Juniors are defined as riders who have not reached their 18th birthday as of December 1st, 2009.**

## **2010 Points**

Points for each show, and cumulative season points will be maintained on the GRHSA website. Each location is responsible for delivering show results to the GRHSA Secretary within 10 days of show completion. The GRHSA Secretary will have points posted to the website within 2 weeks of receipt. Please check these points frequently for any errors. Report any discrepancies to the GRHSA Secretary by August 1st for March through June shows. Report any discrepancies to the GRHSA Secretary by December 1st for July through October shows. All entries received after Thursday prior to the show, will be considered post entry. Post entries will be assessed a \$10.00 processing fee per horse/pony/rider. Short Stirrup is \$40, all other Divisions are \$30. Individual classes are \$15 each. California Warm-Up is \$5 and may only be used once per show.

Entering a class or schooling at this show constitutes agreement that the exhibitor will not hold farm management and volunteers responsible for any loss or injury occurring before, during, or after the show.
